<p>Project Name or Project/ Program Title City of Jersey City - HPRP Program</p> <p>Quarterly Activities/ Project Description The City of Jersey City awarded HPRP monies to two (2) non-profit agencies. One agency was selected to provide financial assistance and diversion services; the other to provide rapid re-housing assistance. To date agencies are still inundated with calls, encountering constituents ineligible due to a history of chronic homelessness, unable to meet sustainability requirements and having income above 50% of the AMI. During the reporting period the prime and sub recipients have met/interfaced to discuss ways to outreach eligible participants and promote program efficiency. The influx of Jersey City residents being displaced by fire and/or inhabitable living conditions has increased the case load for both agencies. The housing locator is unable to place qualified families due to units failing inspection, household incomes unable to afford rents suited for household size and that are HQS approved and other housing barriers congruent to area demographics. Aside from the barriers, the program has had several success stories. Families improving quality life, resuming and/or accessing employment, and creating hope where there was once doubt.
