The City of Jersey City is looking for a licensed Building Inspector or Planner who will be responsible for inspecting new and existing buildings and structures to ensure compliance with the State Uniform Construction Code and public safety, health, and welfare.

#### **Job Duties:**

- Assists in planning, organizing, coordinating, and directing the operations of the Inspection Services.
- Applies independent judgment in defining and assigning projects, work methods, techniques, and procedures.
- Assists in providing leadership, direction, and guidance in technical processes and procedures.
- Manages implementation and enforcement of building safety regulations.
- Review land redevelopment proposals and determine compliance with state, county, and/or municipal regulations.
- Manages inspection services, plan review, and permitting services.
- Assists as principal advisor.
- Inspects construction jobs, checks quality and amount of work completed, and resolves construction problems.
- Examines plans for new structures to ensure compliance with building subcodes.
- Enforces rules and regulations regarding building subcodes and initiates legal action against violators of building subcodes.
- Coordinate and review redevelopment activities with other City departments, outside agencies, and developers.

- Knowledgeable in codes of practice, site reporting, overseeing site programs, and client liaison. of basic material standards, codes, and enforcement requirements related to the weatherability and durability of installed construction materials.
- Able to prepare violation notices and prescribed inspection record keeping,
- Ability to carry out provisions of the State Uniform Construction Code as they relate to residential and small commercial structures.
- Proficient in preparing building construction plans and specifications and able to review others'
  work for accuracy and feasibility.
- Work harmoniously with other municipal unit heads, private contractors, and architects.
- Capable of making investigations, inspections, and clear and concise reports.
- Ability to prosecute violations of the building code by appearing in court.
