THE NEW JERSEY LANDLORD REGISTRATION ACT INSTRUCTIONS

In accordance with <u>N.J.S.A.</u> 46:8-28, <u>every</u> landlord of a residential dwelling, except an owner-occupied dwelling, must file a Landlord Registration Form.

A landlord who owns a dwelling with <u>less than three (3) rental units</u>, except an owner-occupied dwelling, must complete the attached Landlord Registration Form and file it with the City Clerk.

A landlord who owns a dwelling with <u>more than two (2) rental units</u>, except an owner-occupied dwelling, must complete the attached Landlord Registration Form and file it with the New Jersey Department of Community Affairs - Bureau of Housing Inspection. Completed Landlord Registration Forms must be mailed to the following address:

The Department of Community Affairs will forward a filed copy of the Landlord Registration Form to the City Clerk.

In accordance with N.J.S.A. 46:8-28-29, landlords are also required to provide each tenant with a filed copy of the Landlord Registration Form. The landlord should have the tenant sign and date a copy of the Form "received" when the tenant moves in and the landlord should include a copy of the Landlord Registration Form signed and dated by the tenant with the tenant's permanent file.

LANDLORD REGISTRATION FORM

THE LANDLORD REGISTRATION ACT

By law, every landlord of a dwelling, except owner-occupied premises with not more than two rental units, must file with the clerk of the municipality in which the residential property is situated, or with the Bureau of Housing Inspection in the Department of Community Affairs, a certificate of registration.
