### Proof of Rabies Vaccination or Exemption Letter

All applications require a copy of the rabies vaccination certificate showing it to be **valid through the license period** and attached to the application when filed. Dogs incapable of being inoculated are exempted when certified in writing by a duly licensed veterinarian (Original exemption letter or NJ VPH-28 "CERTIFICATE OF EXEMPTION" form is required).
